

# Privacy policy for the website

## § 1 Information about the collection of personal data

(1) In the following we would like to inform you about the collection of personal data when using our website. Personal data is any data personally related to you, e.g. name, address, e-mail addresses, user behaviour.

(3) When you contact us by email or through a contact form, we will store the information you have provided (your email address, your name and your telephone number if necessary) in order to answer your questions. We delete the data collected in connection with this once storage is no longer required or restrict the processing thereof if there are statutory retention requirements.

(4) If we use contracted service providers for individual functions of our service or would like to use your data for advertising purposes, we will inform you in detail below about the respective processes. In doing so, we also stipulate the specified criteria for the storage duration.

## § 2 Your rights

(1) You have the following rights with respect to the personal data concerning you:

- > Right to information
- > Right to correction or deletion
- > Right to limit processing
- > Right to object to processing
- > Right to data transferability

## § 3 Collection of personal data when visiting our website

(1) If you merely use the website for informational purposes, i.e. if you do not register or otherwise provide us with information, we will only collect the personal data that your browser transmits to our server. If you wish to view our website, we collect the following data that is technically necessary for us to display our website and to ensure its stability and security (the legal basis here is Art. 6 para. 1 sentence 1 (f) GDPR):

- > IP address
- > Date and time of access
- > Time zone difference to Greenwich Mean Time (GMT)
- > Content of the request (specific page)
- > Access status / HTTP status code
- > The volume of data respectively transferred
- > Website from which the request originates
- > Browser
- > Operating system and its GUI
- > Language and version of the browser software

(2) In addition to the aforementioned data, cookies are stored on your computer when you use our website. Cookies are small text files that are stored on your hard drive assigned to the browser you are using and by which the entity that sets the cookie (here us) receives certain information. Cookies cannot run programs or transmit viruses to your computer. They serve to make the internet offer more user-friendly and effective overall.

(3) Use of cookies

- a) This website uses the following types of cookies, the scope and operation of which are explained below:
  - Transient cookies (see b)
  - Persistent cookies (see c)
- b) Transient cookies are automatically deleted when you close the browser. These include session cookies in particular. These store a so-called session ID, with which various requests from your browser can be assigned to the common session. This will allow your computer to be recognised when you return to our website. The session cookies are deleted when you log out or close the browser.
- c) Persistent cookies are automatically deleted after a specified period, which may differ depending on the cookie. You can delete the cookies in the security settings of your browser at any time.

- d) You can configure your browser setting according to your wishes and, for example, refuse to accept third-party cookies or all cookies. Please be aware that you then may not be able to use all features of this site.

#### (4) Analysis tools and advertising

- a) Google Analytics: This website uses functions of the web analytics service Google Analytics. The provider is Google Inc., 1600 Amphitheater Parkway, Mountain View, CA 94043, USA. Google Analytics uses so-called “cookies”. These are text files that are stored on your computer and that allow an analysis of the use of the website by you. The information generated by the cookie about your use of this website is usually transmitted to a Google server in the USA and stored there. Google Analytics cookies are stored on the basis of Art. 6 para. 1 (f) GDPR. The website operator has a legitimate interest in analysing user behaviour in order to optimise both its website and its advertising.
- b) IP anonymisation: We have activated the IP anonymisation function on this website. As a result, your IP address will be shortened by Google within member states of the European Union or in other contracting states of the Agreement on the European Economic Area prior to being transferred to the USA. Only in exceptional cases will your full IP address will be transferred from Google to the USA and shortened there. On behalf of the operator of this website, Google will use this information to analyse your use of the website, to compile reports on website activity and to provide other services related to website activity and internet usage to the website operator. The IP address provided by Google Analytics as part of Google Analytics will not be merged with other Google data.
- c) Browser plug-in: You can prevent the storage of cookies by making corresponding changes to your browser settings; however, please note that in this case you may not be able to use all functions of this website to the full extent. In addition, you may prevent the collection by Google of the data generated by the cookie and related to your use of the website (including your IP address) as well as the processing of this data by Google by downloading and installing the browser plug-in available via the following link:

- e) Order data processing: We have entered into a contract data processing agreement with Google and are fully implementing the strict requirements of the German data protection authorities when using Google Analytics.
- f) Demographics in Google Analytics: This website uses the demographics feature of Google Analytics. As a result, reports can be produced that contain statements on the age, gender and interests of the site visitors. This data comes from interest-based advertising from Google and third-party visitor data. This data cannot be assigned to a specific person. You can disable this feature at any time through the ad settings in your Google Account, or generally prohibit the collection of your data by Google Analytics as outlined in the section “Objection to data collection”.
